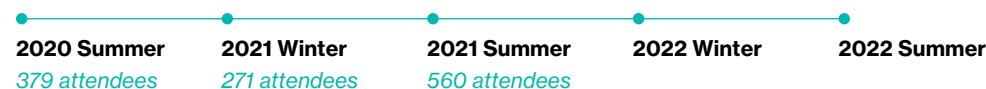

The platform sponsors clickable logo will be displayed in a prime position on the platform for the duration of the event.

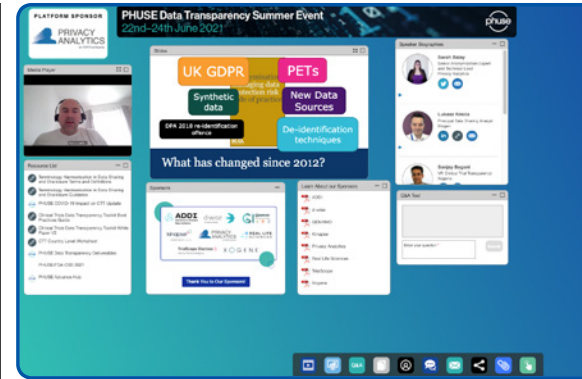


All sponsor logos will be displayed in the e-banner.

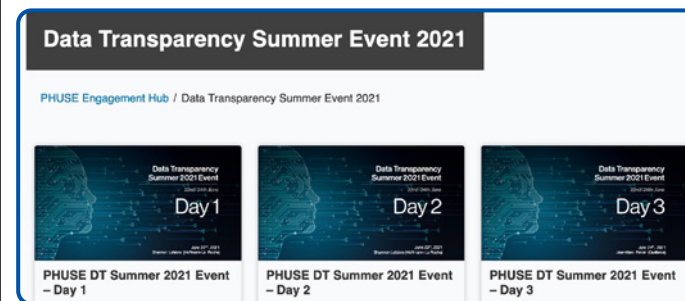
